Minutes of the Parish Council Meeting held on Tuesday 13 January 2009 at 7.30 pm in the Village Hall

- 1. Apologies PCSO K Whitfield
- 2. <u>Declaration of Interest</u> Councillor B Hallam declared an interest on Quotations for the fencing around the Village Pond.

3. Public Questions

3.1 Yellow Lines

In response to a question from Mr J Walton, County Councillor G D Collett informed the meeting that Double Yellow lines would be laid down as soon as possible at the corner of Main Street/Lower Street. With regard to them being laid the whole length of Lower Street as agreed by Rugby Borough Council this depended on the re-introduction of G A Amos Service buses through the Village the viability of alternative "Flexi Buses" through the Village or the continued improvement of parking in Lower Street. The improvements are as a result of monitoring by residents and the businesses in Lower Street.

The Yellow Lines in Daventry Road Dunchurch would be completed once the development work there was finished.

- 3.2 30 mph signs County Councillor G D Collett to raise again with the Highways Department the moving of the 30 mph sign in Lower Street to a point past the pond.
- 3.3 <u>Heavy Lorries</u> Rugby Borough Councillor R Hazelton to approach Highways Department regarding the updating or refurbishment of the 7.5 Tonne Sign at the entrances to the Village. Villagers have again indicated that Heavy Lorries are using Willoughby as a short cut to the A45 and DIRFT.
- 3.4 <u>Speeding on A45</u> County Councillor G D Collett reported that the recently introduced safety measures on the A45 had reduced the average speed by 10% (Police Survey).
- 3.5 <u>Longdown Lane</u> both the signs at Main Street and Longdown Lane had been replaced, but the one at Longdown Lane had been damaged again. Highways Department to the informed.

County Councillor G D Collett left the meeting.

3.6 Rugby Borough Councillor R Hazelton informed the meeting that Speed Camera's would be in action at the junction of Main Street and the A45 in the immediate future.

- 3.7 <u>46/48 Main Street Drains</u> the problem of flooding in the garages of 46/48 Main Street was again raised with RBC R Hazelton and he said that at present a stalemate existed between the Engineers and residents, but that P Byrne the Highways Engineer was investigating.
- 3.8 <u>Flooding in Main Street</u> Villagers stated that during the recent flooding the situation was made worse by 4x4 vehicles ploughing through the flood causing a wash which was entering homes. RBC R Hazelton said that Highways Engineers could only post Flood Notices as only the Police could close the road.

Rugby Borough Councillor R Hazelton left the meeting.

3.9 J Edgar supported by V Whitworth raised concerns regarding the Planning Application for the erection of a Barn on land off Moor Lane (Bath Farm).

The Parish Council had formally objected to this application on the grounds that the Barn was too large and not necessary for a piece of land of only four and half acres. Objections were also raised in that this development if passed could lead to similar applications on each of the remaining small plots giving the development a "Shanty Town" appearance.

Councillor R Heckford said that permission for one would mean permission for all other plots. The meeting was informed that an Article 4 had been placed on the land such that no Containers could be put on the land, no fencing erected or any other alterations made without planning permission.

Councillor M Thomas agreed to take up with the Planning Department the access road which had been laid in the development.

Meeting agreed that Councillor Heckford should raise with the Planning Authorities the Council's concerns regarding this development, its impact on the Village and report back at the next meeting as to any recommended Parish Council actions.

V Whitworth, J Edgar, J Walton, B Walton, B Troman, W Hewitt left the meeting.

- Minutes On the proposition of Councillor Heckford, seconded by Councillor Belgrove the minutes of the meeting on 4 November were approved as a true record and signed by the Chairperson.
- Police Report A burglary in Pye Court and a break in to a Car in College Road had taken place.

A quotation for fencing around the Pond has been received from B Hallam, agreed that other Contractors be contacted for alternative quotations before a final decision was made.
