Minutes of the Parish Council Meeting held on Tuesday 19 May 2009 at 7.30 pm in the Village Hall

Members Present: Councillors M Thomas (Chairperson), B Hallam, A Belgrove T Thomas, R Heckford and the Clerk

Members of the Public Present: Rugby Borough Councillor R Hazelton (part meeting)

<u>Chairperson</u> – on the proposition of Councillor Heckford seconded by Councillor Belgrove, Councillor M Thomas was elected Chairperson of the Parish Council for the coming year.

- 2. <u>Declaration of Interest</u> None declared
- 3. Public Questions None
- Minutes Minutes of 24 March 09 approved as a true record on the proposition of Councillor Hallam, seconded by Councillor Heckford.
- Police Report Clerk read out to the meeting the latest Police report for Willoughby
- 6. Rugby Borough Councillor R Hazelton advised the meeting on the following issues:
- 6.1 Pye Court County Councillor G D Collett & Councillor M Thomas had met with Mr P Cowley of Highways Department and agreed for resurfacing with chippings of the lane leading down Pye Court.
- 6.2 Shrubbery Footpath agreed with Mr P Cowl for Footpath Department to clear and strim sides of Shrubbery Footpath, no remedial work on path surface to be carried out.
- 6.3 Verge Mowing Clerk to request Contractor to strim back verge alongside the footpath leading from Main Street (No: 44) through to Magdalen Road.
- 6.4 Lower Street Council to approach owner of No: 1 White Barn Close to have hedge severely cut back to original position as it had become dangerous for pedestrians to use the footpath.
- 6.5 Land off Moor Lane Council advised that the Article 4 placed on this development had been suspended awaiting Planning decisions on Planning applications placed.
- 6.6 Council advised that Caravan at Willoughby Fields Farm, London Road, Willoughby although only moved to another part of the site would be removed from the site.
- 6.7 A45 Footpath RBC R Hazelton reported that the proposed Cycle Path from Dunchurch through to the Northamptonshire border was now in doubt due to financial constrictions.
- 6.8 Bus Tokens Council advised that Bus Tokens had now been replaced with the Mini-bus Scheme. The Mini-bus would operate in Willoughby on Fridays and villagers were asked to contact Rugby Borough Council to register in order to use the scheme. This service did not affect the issuing of Bus Passes.

6.9 RBC R Hazelton repeated his advice for the Parish Council to develop a Village Design Statement/Parish Plan.

7. Planning Applications

- 7.1 Moor Lane The Planning application for the erection of a Barn on land off Moor Lane had been withdrawn.
- 7.2 Mr Janusz Prymaka had advised the Parish Council that a Planning application would be made in the near future for a conservation and rehabitation Birds of Prey Centre off the A45 opposite Haywards Lodge. Presentation Packs for individual Councillors would be made available.

8. CORRESPONDENCE

- 8.2 A quotation for Civil Engineering work at the Village pond had been received, Council decided to hold until after dredging had taken place.
- 8.3 Approved Contractors Council have decided to prepare a list of Approved Contractors who would then be invited to quote for any projects which will be undertaken by the Council. Clerk to place notice on Notice Board inviting local Contractors to have their names included on Approved Contractors list.
- 9. 9.1 (Agenda 9.2) Councillors M Thomas, B Hallam and the Clerk had visited sites with "Husson" Playground Equipment and found the quality to be acceptable. On the proposal of Councillor Heckford seconded by Councillor Hallam agreed to place order with Husson for Playground Equipment as per their quotation No: QUK 1949-R2 minus the supply and spread of Playgrade Bark in existing loosfill pit under swings.
 - On the proposition of Councillor Hallam, seconded by Councillor Heckford agreed that Councillor T Thomas should order two bags of Playgrade Chippings to enable Councillor to spread them under the existing swings themselves, bags to be delivered to R Heckford for safekeeping until laid prior to Willoughby Weekend. The painting of the existing Roundabout is expected to be completed prior to the Willoughby Weekend.
 - Councillor T Thomas to chase Contractor regarding the design and building of a Shelter in the Playing Field.
 - 9.2 (Agenda 9.3) Clerk had attended a meeting regarding the Village Leader Project the outcome of which is still unclear, Clerk to follow up.
 - 9.3 (Agenda 9.4) Willoughby Weekend ongoing.
 - 9.4 (Agenda 9.4) An update on the "Information Packs" for monitoring Heavy Lorries using the Village as a short cut is awaiting from Warwickshire County Council.
 - 9.5 (Agenda 9.7) Affordable Housing response still outstanding Council are to establish if the original survey is still relevant to current needs and is not the potential cost of repeating the survey.
 - 9.6 (Agenda 9.9) Parish Plan meeting agreed that when completing the Parish Plan the Village should be designated as a Conservation Village.
