Minutes of the Parish Council Meeting held on Tuesday 24 March 2009 at 7.30 pm in the Village Hall

- 1. Apologies PCSO K Winfield
- Declaration of Interest Councillor B Hallam declared an interest on payment for the fencing around the Village pond. Councillor T Thomas declared an interest on clearing up of Shrubbery Footpath.
- 3. Public Questions None
- 4. <u>Minutes</u> On the proposition of Councillor B Hallam, seconded by Councillor Heckford the minutes of the meeting on 24 February 2009 were approved as a true record and signed by the Chairperson.
- 5. <u>Police Report</u> A report on Police incidents (24:02:09 24:03:09) had been received from PCSO K Winfield and this was circulated to the Councillors.
- 6. County Councillor G D Collett and Rugby Borough Councillor R Hazelton
- 6.1 (Agenda 9.1) Yellow Lines now completed at junctions of Lower Street and Main Street.
- 6.2 Next Dunchurch Divisional Panel to be held in Willoughby Village Hall on 17 June at 7.30 pm.
- 6.3 Moving the 30 mph Signs in Lower Street has been placed in Highways programme and will be actioned shortly. RBC R Hazelton to take up with Highways the possibility of providing chicanes at both entrances to Willoughby. The cost of these would be expected to be in excess of £40,000 for each entrance.
- 6.4 Lowering the height and contours of the road at the Bridge (Moor Lane/Lower Street) to see if during flooding water could be prevented from running down Lower Street has been given an estimate in excess of £100,000 and therefore unlikely to be undertaken.
- 6.5 Land off Moor Lane Parish Councillors totally dissatisfied with the enforcement actions undertaken by RBC Planning Enforcement Officers and will now raise issue with J Wright MP for assistance. RBC R Hazelton to raise Parish Council's dissatisfaction with RBC Planning Head.
 Parish Chairperson and Clerk to attend meeting on Gypsy sites at the Town Hall

on 2 April. As yet no decision as to the status of the erection of a barn on one plot of this land is known.

County Councillor G D Collett left the meeting.

- 6.6 (Agenda 9.9) RBC R Hazelton had obtained a leaflet on 'A Guide to developing Parish Community Emergency Plan' – agreed Chairperson and Clerk would establish how our existing Community Emergency Plan complied with these guidelines.
- 6.7 (Agenda 9.7) 'Information Packs' for monitoring Heavy Lorries using the Village as a short cut were being completed by several Villagers. Additional packs are still available if required.
- 6.8 Mineral Plan RBC R Hazelton raised the concern of additional lorry movement along the A45 if Mineral development takes place alongside the straight mile (Bourton).
- 6.9 (Agenda 9.11) A quotation had been obtained for clearing the Shrubbery Footpath at both ends and this has been forwarded to the Highways Department for action either to finance it through Willoughby Parish Council or to undertake the work themselves, as yet no response had been received. RBC R Hazelton to chase Highways Department. On the proposition of Councillor B Hallam seconded by Councillor Heckford agreed to go ahead with quotation from T J Thomas Landscape Contractor for £250 if negative response received from Highways Department.

Rugby Borough Councillor R Hazelton left the meeting.
